Biomaxx

The Town Manager discussed transitional authorization, which gives the town an extension until the end of 2030 or 2040 to complete upgrades and meet the effluent standards under the federal Wastewater Systems Effluent Regulations. Biomaxx advised that they would do an agreement for \$1,500. Once the agreement was completed and accepted by the government, there would be a savings of \$1,674 for sampling per year.

Mayor Lodge provided notes from the Municipalities Symposium that the town can apply for Transitional Authorization. He will forward the information to the Town Manager.

The town agrees to provide its share of the cost-shared funding, \$156,682, for this project should it be selected for funding, and acknowledges that project costs above the approved project total cost will be the sole responsibility of the Town of Trinity Bay North.
