The Town Manager advised this number was to low to do the work that was required to keep the playground equipment sanitized. He advised that he took the rules sign down and replaced it with "Use at your own risk" sign.

8) Water Resources

It was advised that the Johnson Screen will not work no differently than our current screen.

Manganese – Mayor Blackmore stated that Health Canada should have some guidelines on how to rectify manganese in water supplies. She suggested we sit down with our engineering firm to see if there is anything that we can install on our water system to help reduce the amount of manganese in our supply.
