#### **Fire Inspections**

### Crown Lands (LTO)

Mayor Lodge reported that MHA Pardy contacted him advising that Crown Lands is now allowing some towns with historical significance to issue Crown Land certificates. He thinks that Trinity Bay North would qualify based on the age of Catalina Harbour; therefore, he should write a letter to the Minister of the Department of Fisheries, Forestry and Agriculture requesting Trinity Bay North be granted the right to issue Crown Land Certificates within its boundaries based on historical taxation records.
