	2) Tender (Sweetland's Aggregate)

Be it resolved we award the tender for the construction of ADA washrooms, an enviro septic system and an artesian well system in Lookout Park to Sweetland's Aggregate Ltd. in the amount of \$112,700 plus HST.

3) Iceberg Harvester Barge

Recreation An estimate was received from Lawrence Mackey to replace the floors in the washrooms at the Melrose chalet in the amount of \$2,803.00.

It was decided before a decision is made on the future of the Melrose Chalet a full cost analysis has to be completed i.e. water/sewer installation, roofing and repairs to inside of building.
